EXTRA WIDE CONCRETE PORCH WITH STONE BALUSTRADE FEATURING PRAIRIE URNS. HOUSE HAS FEWER ROOMS THAN EXPECTED - FEATURES GIGANTIC FOYER, HUGE LIVING ROOM, HUGE DINING ROOM & MEDIUM KITCHEN COMPRISE FIRST FLOOR. RATHER SEVERE OAK WOODWORK ON INTERIOR. SIMILAR TO BARTERT HOUSE AT 1850 JERSEY STREET. THE DUKER HOUSE IS RELATED TO TWO DESIGNS BY W. BURLEY GRIFFIN - THE JOSHUA MELSON HOUSE IN MASON CITY, IOWA, AND THE STINSON
