DESCRIPTION SMALL SIMPLIFIED GOthic, WITH SEMI CIRCULAR FRONT PORCH. COLUMNS
ARE SQUARE WITH ALL FOUR SIDES DEEPLY CARVED TOPPED BY MULTI-
MOLDED LAYERS. SMALL NEAT BRACKET PAIRS UNDER SHALLOW
PORCH ROOF EAVE. ENTRY VESTIBULE EXTENSION ON FRONT
PORCH IS TOPPED BY SECOND FLOOR DORMER PITCHED AT ABOUT
30° RECTANGLE WINDOW IN DORMER IS CAPPED WITH LOVELY
INTRICATELY CARVED SUNBURST PANEL. CENTRAL DORMER IS
FLANKED BY SMALLER DORMER ON EACH SIDE. THESE EACH
FEATURE TWO NARROW GOthic ARCHED WINDOWS WITH CENTRAL
DOTS. DIAMOND FINISH DECOR ABOVE WINDOWS AND FITTING UNDER
RABE. EAST SIDE OF HOUSE FEATURES SMALL 3-SIDED BAY ON
FLOOR LEVEL TOWARD REAR. SMALL BAY ON WEST SIDE NEAR FRONT OF PORCH.
