CUPOLA; IN FRONT OF CUPOLA IS DORMER WHICH IS EXTENSION OF  
FACADE OF HOUSE CUT THROUGH CORNICE. CORNICE IS DOUBLE  
BRACKETED - FRIEZE FEATURES CORBELLED & ACUTING ORNAMENTATION.  
ALL WINDOWS HAVE ARCHED CORBELLED CORNICES. CORNERS  
OF BUILDING HAVE BRICK QUAINING. LOCAL ENTRY DOORS  
HAVE SEGMENTED TRANSOMS. 1ST FLOOR AREA. WINDOWS ARE  
FLOOR LENGTH. OFFSET ENTRANCE ON NORTH SIDE OF HOUSE  
ENTERS SHALLOW NORTH WING. SOUTH SIDE OF HOUSE HAS  
ONE STORY ANGULAR BAY. FOUNDATION OF HOUSE UNUSUAL  
DIMPLED CUT STONE COURSED. REAR SERVICE WING NOT AS  
TALL (2 STORIES) AS MAIN STRUCTURE - 5' 0"
